Rhizolizer® Duo augments natural microbial activity in the rhizosphere of agricultural soils. It supports nutrient availability and crop nutrient uptake from the soil.

For commercial agricultural use only.

SHAKE OR STIR WELL BEFORE USE

DIRECTIONS FOR USE

Apply at 3-12 fl oz/acre; up to 6 applications up to 36 fl oz/acre per growing season. Fill mixing tank to a minimum of 50% volume, begin agitation, add Rhizolizer Duo, and fill with remainder of required volume. Agitate throughout application.

Applications may be made at planting and in-season through ground, chemigation and fertigation methods.

Rhizolizer Duo should be applied within 8 hours of mixing. It can be used in tank mixtures and applied with some agricultural fertilizers and blends. Contact Locus AG to ensure compatibility.

Do not tank mix with or apply directly after some agricultural fungicides or antimicrobials. Do not apply with UAN. Can be applied with CAN-17, 10-34-0 and 6-24-6. Not recommended for use as a fertilizer substitute. Conduct a jar test to assure tank mix compatibility. See Locus compatibility guidelines for more information.

Berries, Potatoes/Sugarbeets, Vegetables, Tree Fruits, Tree Nuts and Vines:

Apply 3-12 fl oz/acre as in-furrow at planting, at or after transplanting. For subsequent applications, apply 3-12 fl oz/acre through ground, surface directed or broadcast spray, drench or irrigation.

Other Specialty Crops:

Apply 3-12 fl oz/acre as in-furrow at planting, during or after transplanting. For subsequent applications, apply 3-12 fl oz/acre through ground, surface directed or broadcast spray, drench or irrigation.
