## PRODUCT DESCRIPTION

Rhizolizer\* Duo augments natural microbial activity in the rhizosphere of agricultural soils. It supports nutrient availability and crop nutrient uptake from the soil.

For commercial agricultural use with approved seed treaters only.

# **DIRECTIONS**

#### INVERT 5-10 TIMES BEFORE USE

**Apply at 0.16 fl. oz. per unit of seed (50lbs bag).** This 128 fl. oz. container treats 800 units. One case treats 1,600 units.

#### **Directions for Use**

- First add the desired quantity of non-chlorinated water and liquid seed treatment products to the tank.
- 2. Start tank agitation and maintain agitation at all times.
- Measure appropriate amount of Rhizolizer Duo Seed Treatment for Wheat & Cereals and add slowly to the mix tank.
- 4. Ensure the liquid mixes completely into the slurry.
- 5. Apply to seed.

### Compatibility

Rhizolizer Duo Seed Treatment for Wheat & Cereals is compatible with many common seed fungicides and insecticides. For current compatibilities, contact your Locus Agriculture representative or call (888) 331-5008.

#### Tank Mix Restriction

Rhizolizer Duo Seed Treatment for Wheat & Cereals can be left in the tank mix for 4 hours with chemistry and 24 hours in non-chlorinated water alone. If this time is exceeded, discard the material or add more Rhizolizer Duo Seed Treatment for Wheat & Cereals.

Store in a cool dry place out of direct sunlight  $40^{\circ}$ - $77^{\circ}$  F. **Do not freeze.**
