DIRECTIONS FOR USE

Reference the table above for application methods and rates. When surface applied, light incorporation or adequate moisture is required shortly after application to move Terradigm XP into the root zone.

Fill mixing tank to a minimum of 50% volume, begin agitation, add appropriate amount of Terradigm XP, then fill with remainder of required volume. Continue tank agitation throughout application.

Terradigm XP should be used within 8 hours of mixing. It can be applied with some horticultural fertilizers and blends. Contact Locus AG to ensure product compatibility.

Do not tank mix with or apply directly after agricultural fungicides or antimicrobials. When applying with UAN-32 or UAN-28 dilute every gallon of fertilizer in the tank mix with 10 gallons of water. Not recommended for use as a fertilizer.

SHAKE OR STIR WELL BEFORE USE

STORAGE AND DISPOSAL

Storage: Keep refrigerated (36-50°F). Use within two weeks after removal from refrigeration. Store in original container only. Keep out of direct sunlight. Use full contents of container after opening.
